The Bids will be opened in the presence of Bidders' representatives who choose to attend **28th April, 2019 (15th Baishakh, 2076)** at 14:00 hours at Metropolitan Traffic Police Division Ramshapath, Kathmandu, Nepal. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
